HKAS is a member of the International Accreditation Forum (IAF), International Laboratory Accreditation Cooperation (ILAC), Pacific Accreditation Cooperation (PAC) and Asia Pacific Laboratory Accreditation Cooperation (APLAC). HKAS is also a signatory to the multilateral mutual recognition arrangements of these cooperations. All together under these arrangements, HKAS has 84 mutual recognition arrangement partners in 67 economies.
